

# ITINEO – Facebook and Instagram Competition Rules

## INSTAGRAM COMPETITION RULES – ITINEO

### 1. Organizer

This competition is organized by Rapido SAS, whose registered office is located at:

### 2. Name of the competition

The competition is called: “France Passion x Itineo Instagram Competition”.

### 3. Competition dates

The competition will take place on Instagram from Friday 6 March 2026 at 6:00 pm (Paris time) to Friday 20 March 2026 at 9:00 am (Paris time).

Any participation outside these dates will not be taken into account.

### 4. Conditions of participation

The competition is open to any person residing in Europe, aged 18 or over, with a public or private Instagram account.
